RIGHT TO BE FORGOTTEN  
RIGHT OF ACCESS  
RIGHT TO RECTIFICATION  
RIGHT TO ERASURE  
RIGHT TO RESTRICT PROCESSING  
RIGHT TO DATA PORTABILITY  
RIGHT TO OBJECT  
RIGHTS RELATED TO AUTOMATIC PROCESSING AND PROFILING

CONSENT: ONE POSSIBLE LEGAL BASIS  
MUST BE UNAMBIGUOUS & INVOLVE A CLEAR AFFIRMATIVE ACTION  
CLEAR RECORDS TO DEMONSTRATE CONSENT  
RIGHT TO WITHDRAW CONSENT  
GRANULAR CONSENT FOR DISTINCT PROCESSING OPERATIONS  
BANS PRE-TICKED OPT-IN BOXES  
SEPARATE FROM OTHER TERMS AND CONDITIONS

RISKS - FROM A LOSS OF SENSITIVE DATA
